



ToR: Policy and **Technology**

Services for the International Aid Transparency Initiative

Functions:

- 1. Stewardship of the IATI Standard
- 2. Technical infrastructure
- 3. Publisher and User Support
- 4. Community and Communications
- 5. Policy and Planning Services

Accountability Structure

Provide an Executive Director (ED) function reporting to Governing Board & members annually

Skill and experience:

- Improving validation, accessibility & use qualitative and quantitative aspects of development and humanitarian support;
- Maintaining and improving data standards
- Providing technical support / tools to publishers
- Collaborating with a wide variety of stakeholders e.g. donors, CSOs etc
- Advocating for IATI on a global level
- Providing information, support and outreach services in multiple languages
- Providing Secretariat functions to international stakeholders



ToR: Legal and **Operational Support**

Services for the International Aid Transparency Initiative

Functions:

- 1. Operational and Financial management
- 2. Procurement and contract management

Accountability Structure

Provide a service/relationship manager function reporting to the Executive Director of the host, and to GB quarterly, and IATI members annually

Skill and experience of

- Drafting and managing contracts for complex IT projects
- Financial management and accounting capacity
- Procurement and contract management (experience in procurement with local partners / in languages other than English is essential
- Experience as a fiscal sponsor working with diverse groups of international stakeholders

Final TORs and bid process published.

IATI's Community is invited to suggest organisations for Board to approach to encourage them to bid. Nov - Dec 2022

Search and approach

Board/IWG sub group approaches selected organisations to submit a bid. Any other organisation is also welcome to submit a bid.

IWG/Board develops longlisting/shortlisting selection criteria Jan- mid Feb 2023

Bid submission closes / longlisting & shortlisting

Bid submission closes on 6 Jan.

Process Manager & IWG longlist bids

Selection panel shortlist bids and shares 2-3 options for both TORs with Board End of Feb 2023

Preferred hosts recommended to members

Board selects preferred host(s) to deliver each of the TORs.

Board sends written recommendation of preferred host(s) and provider(s) to members for their consideration. 13-16 Mar 2023

Members' Assembly vote

Members' discuss the Board's recommendation at Members' Assembly.

Decision is voted on by eligible members to enable Board to enter final negotiations with hosts and sign LoA

Bidding Process

Can one proposal be submitted for both ToRs?

Yes, provided all requirements for both ToRs are addressed.

Can several organisations partner to deliver one or more of the ToRs?

Yes, as long as the partners act and deliver as "one", demonstrating clear lines of accountability via the executive director to the Governing Board and members.

Is there a possibility that the deadline for the submissions of proposals will be extended?

This is highly unlikely as we need to review the proposals and make a recommendation in time for the Members' Assembly in March 2023.

How is the Board ensuring a robust and transparent process for the selection?

- The process is fully **open** to any organisation that wants to submit a proposal
- All information about the process is published online
- All organisations will be assessed against the selection longlisting and shortlisting criteria (currently being defined by the IWG and the Board for publication).

Why were current hosts not extended?

IATI has grown and expanded over the past 10 years and this was seen as a good opportunity to scale the initiative to new heights through new updated Terms of Reference, and to open the field to potential new suppliers. Current hosts were explicitly encouraged to consider participating in the bid, either jointly or separately.

What is the most important priority for the new hosts to deliver on? Priorities agreed by members are clear in the Strategic Plan 2021-25, which remains our guiding document.
