## IATI Members Advisory Group (MAG) - Meeting Minutes 18.9.15

#### **Attendees**

### 1) Chairing / Logistical Arrangements for the MAG

- Robin Uyterlinde (IATI Steering Committee Chair) will Chair the MAG supported by Jamie Attard (Gates Foundation) and Sarah Johns (Bond) as Co-Chairs in the event he is unavailable. Minutes of meetings will be available on the IATI website and shared through the IATI SC Bulletin.
- With the representative from Moldova moving to a new role outside of the Moldovan Government, members thanked Ms Ciurea for her support but agreed that UNDP should lead in identifying a partner country member to join the MAG in place of Moldova.
- The MAG will have a virtual meeting every two weeks and will consult other SC members as necessary between meetings to advance specific discussions.
- Annelise Parr (Coordinator IATI Secretariat) will propose a bi-weekly schedule and circulate agendas and relevant background documents.

#### 2) MAG Terms of Reference

- Members reviewed the Terms of Reference for the MAG for the 3-month period leading up to the
  December, 2015 IATI Steering Committee meeting, and clarified that the intent of the group is to
  conduct preliminary analysis and consultations to empower the Steering Committee in
  December to make the necessary decisions on the subjects of governance, hosting and strategic
  vision for the future of IATI. The group will not make any key decisions on behalf of the Steering
  Committee.
- The MAG's key roles were agreed as the following:
  - Taking the IATI Evaluation recommendations into consideration, assist in preparing for Steering Committee discussions and decisions on the key issues of governance during the December 2015 meeting;
  - Prepare for a discussion around strategic vision of IATI, (purpose, goals, values and principles) by SC members at its December meeting; and
  - Prepare recommendations on future hosting process for the December 2015 meeting.
- MAG will begin to address future hosting arrangements and requested further information from the IATI Secretariat on the logistical / legal means for extending current hosting arrangements, in addition to details on the handover from DFID to the current Consortium.
  - The MAG will organise a call without IATI Secretariat members present after the above information is available, to begin discussions around the future hosting process with a view to providing recommendations on how to take this process forward by the December SC meeting.

# **3) Agreed Outputs for the December, 2015 Steering Committee meeting (TBC in future MAG meetings)**

- Recommendation for consideration and decision by members on long term changes to the governance structure.
- Draft outline of the strategic vision of IATI.
- Recommendation on future hosting process and associated short-term actions.
